Commerce Recreation Grant Guidelines

The Commerce Recreation Advisory Board allots grants for the purpose of partially funding activities for our area youth. Assistance is provided for those who demonstrate financial hardship by an official state agency or meet the guidelines of the Grant Award Chart.

- A separate application must be submitted for each activity which funding is requested
- Assistance is not available for all programs
- Grants are for registration fees only
- Grants cannot be used for deposits, late fees or any other costs associated with participation
- If you are awarded a scholarship and fail to complete the activity without a written medical reason you may no longer be eligible for monetary assistance from the Commerce Recreation Advisory Board. Any situation other than a written medical reason must be approved by the Commerce Recreation Advisory Board before you will be eligible for additional monetary assistance.

The following written documentation must be submitted along with the grant application:

- **Copy of most recent signed Federal Tax Return**
- **Copy of Photo ID of parent or legal guardian**
- **Most current pay stub**
- **Proof of most recent two months of income**
- **Written documentation of hardship from state agency if necessary (TANF recipients automatically qualify for 80%, PeachCare 40%, Food Stamps 20%)**
